#### **Offer Terms and Conditions**

1. This "**Offer**" is provided to you by BOBCARD Limited ("**Bank**") and Amazon Pay (India) Private Limited (formerly known as Amazon Online Distribution Services Private Limited) ("**Amazon**") and made available on the website [www.amazon.in](http://www.amazon.in) and the mobile site and mobile application thereof (collectively, "**Amazon.in**").
2. These Offer terms and conditions ("**Offer Terms**") are in addition to the Amazon.in Conditions of Use & Sale and Privacy Notice to which you agree to by using Amazon.in. In the event of any conflict between the Conditions of Use & Sale and these Offer Terms, these Offer Terms will prevail, only for the purposes of this Offer.
3. All residents of India holding a valid credit card issued by the Bank (each a "**Card**") are eligible to avail the Offer (each a "**Cardholder**").
4. The offer is valid from 20<sup>th</sup> July 2025 00:00 HRS to 24<sup>th</sup> July 2025 23:59 HRS ("**Offer Period**"), unless revoked or extended by Amazon in its sole discretion, without any prior notice and without liability.
