- 1. In the event of any conflict between the Conditions of Use & Sale and these Offer Terms, these Offer Terms will prevail, only for the purposes of this Offer.
- 3. All residents of India holding a valid credit card issued by the Bank (each a "**Card**") are eligible to avail the Offer (each a "**Cardholder**").
- 4. The offer is valid from 20<sup>th</sup> July 2025 00:00 HRS to 24<sup>th</sup> July 2025 23:59 HRS ("**Offer Period**"), unless revoked or extended by Amazon in its sole discretion, without any prior notice and without liability.
