Frequently asked questions

What is the offer?

Flat INR 500 instant discount on BOBCARD Credit Card transaction on minimum order value of INR 5000 & above

How many times can this offer be availed?

Applicable once per card on Best Price Flipkart Wholesale App or Website and Applicable once per card in-store as well only on Pinelabs POS devices.

What is the offer duration?

The offer is valid from 00:00 hours on 22nd Sep 2025 to 23:59 hours on 28th Sep 2025.

However, BOBCARD and WMI reserve the absolute right to withdraw and/or alter any terms of terms and conditions of the Offer at any time without prior notice.

When will the cashback be credited?

Users will be able to view the discount amount eligible on the Payments checkout Page on the Flipkart wholesale Best Price platform during checkout and on Pinelabs POS machines while paying through eligible BOBCARD bin in-store.

How do I check if the product is an eligible product?

The non-eligible product lists are attached in the T&C.

Offer will automatically apply to eligible products & users will be able to see the discount amount only on the eligible orders.

Is there any exclusion list for instore purchases for BOBCARD offer?

No, there is no exclusion list for BOBCARD credit card offer in-store purchases made via Pinelabs devices, only the minimum amount condition of INR 5000.

Will I get the offer if I pay using BOBCARD Debit or Credit Card via PhonePe/UPI/Net Banking/ Ledger balance?

No, the offer will NOT apply on full or partial payments made from BOBCARD Credit card via UPI payment, Net Banking or Ledger Balance option. To be eligible for the instant cashback offer, the full payment has to be done via credit card payment mode only.

However To avail of this Offer, the purchase should be charged in full to the Credit card. In case a customer makes partial payments through a Gift Card/Wallet, the Offer will apply only to the net eligible amount paid through the Credit card towards the purchase during the Offer Period.
