

## 1. Definitions

- a. Offer: The offer means Get 5% cashback on spend of a total ₹5,000 or more between September 13, 2025, and October 10, 2025 with your BOBCARD on Utilities categories (MCC 4900 & 4899). A maximum cashback of ₹500 can be earned under this offer.
- b. **Offer Period:** The offer period will begin from 00:01 hours on September 13<sup>th</sup> 2025 and will be valid up to 23:59 hours on October 10<sup>th</sup> 2025.
